- A. Paint Games Plus Dist, Inc. reserves the right to refuse to do business with any Buyer, in its sole discretion. Buyer will be notified of any orders which are declined by Paint Games Plus Dist, LLC.
- B. Any returned checks will be charged a \$25.00 return fee and customer terms will be credit card, money order or cashiers check only on any future orders.
- C. All orders are FOB Paint Games Plus Dist, LLC. warehouse.

Returns:

- 1. All returns must be submitted by you and approved by Paint Games Plus Dist, Inc in writing.
- 2. No authorization of returns will be granted for goods more than 30 days past shipping. Credits will only be issued once returns are received and accepted and credit memos are issued.

Warranty:

- 1. Paint Games Plus Dist, Inc. will not warranty any products not manufactured for Paint Games Plus Dist, Inc. and its trademarks.
- 2. Customer must contact the manufacturer for any warranties.
- 3. Karnage Paintballs will have a manufacturer warranty that is free from reasonable defects. Any defective Karnage paintballs sold direct to you, from Paint Games Plus Dist, Inc. will be determined only by Paint Games Plus Dist, Inc. This does not include any freight damage.

Freight damage or claims:

- 1. Customers must write down on the bill of lading any damage, shortage or concerns about the product. If customer does not write it down on the bill of lading, we cannot cover any warranty caused by freight damage or shortage.
- 2. Customer must call Paint Games Plus Dist, Inc. and inform us of any such damage or missing product, within 7- days of delivery.

Proper storage of paint:

When the customer receives paint, customer must store paintballs between 59-86 degrees for any warranty. At delivery paint must warm up or cool down depending on the temperature of the paint at delivery, before being sold to their customers. This warm-up or cool-down could take 24 hours or longer for a skid of paint. To speed up this process, break down the skid and spread out the boxes. Ideal conditions for storing paintballs are between 68 to 72 degrees, with low Humidity.

Customer and guarantors understand and agree that all invoices are due and payable I full within ten (10) days of the date of the invoice. Customer and guarantors agree that all invoices are subject to interest according at the rate of 18% per annum until paid. Guarantors further unconditionally and personally guarantee the full and prompt payment of all sums due Paint Games Plus Dist, LLC. under the terms of this agreement including all cost and expenses of collection. Guarantor hereby waives all defenses to payment under this personal guarantee, including presentment and notice of dishonor. In the event Paint Games Plus, Dist LLC is required to bring an action at law or in equal against customer or guarantor to enforce the terms and conditions hereof, customer and guarantor hereby jointly and severally agree to be responsible for all attorney’s fees and court cost, including expert fees, incurring in the prosecution of any such matter, including a reasonable attorney’s fee. By execution hereof, customer and guarantors expressly agree that any such action against them may be brought in the Circuit Court of Greene County, Missouri, and each party hereby submits to the exclusive jurisdiction of that Court. Further, Customer and Guarantors expressly agree that any action against them will be constructed under the laws of the State of Missouri.
